

A RESOLUTION EXTENDING THE DEADLINE FOR THE SUBMISSION AND OPENING OF BIDS FOR CONSTRUCTION OF THE COLLEGE OF ENGINEERING SCHOOL INFRASTRUCTURE (DESIGN AND BUILD) AND COLLEGE OF LIBERAL ARTS SCHOOL INFRASTRUCTURE (DESIGN AND BUILD);

WHEREAS, the Bids and Awards Committee for Infrastructure advertised the Invitation to Bid for the **CONSTRUCTION OF THE COLLEGE OF LIBERAL ARTS INFRASTRUCTURE (DESIGN AND BUILD)** with an Approved Budget for the Contract (ABC) of **Ninety-Four Million Eighty Thousand Pesos (Php 94,080,000.00)** in the mPhilGEPS website, WMSU Website, and conspicuous places on March 12, 2026;

WHEREAS, the Bids and Awards Committee for Infrastructure advertised the Invitation to Bid for the **CONSTRUCTION OF THE COLLEGE OF ENGINEERING SCHOOL INFRASTRUCTURE (DESIGN AND BUILD)** with an Approved Budget for the Contract (ABC) of **Eighty Million Three Hundred Sixty Thousand Pesos (Php 80,360,000.00)** in the mPhilGEPS website, WMSU Website, and conspicuous places on March 19, 2026;

WHEREAS, after the pre-bid conference held on March 30, 2026 member Engr. Alburo moved to extend the deadline of submission and opening of bids of both projects for a period of Five (5) days in the observance of the Holy Week duly seconded by Member Engr. Limbaga;
