- 1.) A complete set of Bidding Documents may be purchased by prospective bidders from the dates and address indicated above upon the payment of a non-refundable fee in the amount Five Thousand Pesos (Php 5,000.00) to the University Cashier. The Bidding Documents shall be received personally by the prospective bidder or his authorized representative. It may also be downloaded from our website, www.wmsu.edu.ph and PhilGeps Registration provided that the bidders shall pay the nonrefundable fee for the bidding documents from May 24 to June 13, 2024 from 8:00am 5:00pm.
- 2.) All bids must be accompanied by a bid security of at least two percent (2%) of the Approved Budget for the Contract (ABC) in the form of Cash, Cashier's Check or Manager's Check, or Bid Securing Declaration. Bids without Bid Security will not be considered.
- 3.) Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act".
- 4.) Pre-Bid Conference will be on May 31, 2024, 1:30 PM at BAC Office, WMSU, Ground Floor Executive Building, Zamboanga City and/or through video conferencing or webcasting via Zoom, which shall be open to prospective bidders.
- 5.) Bid submission and opening shall be on June 13, 2024 at 1:00 P.M. at BAC Office, Ground Floor Executive Building, WMSU, Zamboanga City, Philippines, 7000. Bids will be opened in the presence of the Bidders representatives who choose to attend at the address above. Late bids shall not be accepted.

The Bidder shall prepare an original of the Eligibility Documents & Technical Components and original of Financial Proposal and clearly mark each "ORIGINAL ELIGIBILITY DOCUMENTS and TECHNICAL COMPONENTS", and "ORIGINAL FINANCIAL PROPOSAL", respectively.
